# **Title IX and Gender-Based Harassment & Discrimination Resource Guide** for students

Title IX is a federal civil rights law that addresses gender-based discrimination. Contained within the Higher Education Amendments of 1972, Title IX states: "No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving federal financial assistance..."

If you or someone you know at Bentley University has experienced sexual violence, relationship violence, gender-based violence, unwanted sexual attention, or any behavior that falls under one of the applicable policies below, there are a number of ways to report the incident and obtain support, if you choose. This guide provides an of resources available both on and off campus, along with some general information about the application of the Title IX and Gender-Based Harassment & Discrimination (GBHD) policy at Bentley. ### If you are seeking resources immediately after an incident, please consider the following options:

#### You are strongly encouraged to seek medical attention.

- During university business hours, you can visit the Health Center in Rhodes Hall or contact their office at 781-891-2222, or Wellness & Prevention in the Callahan Building or contact their office at 781-891-2600
- You can also seek resources at any medical facility. Newton-Wellesley Hospital provides free and confidential domestic and sexual violence services for survivors of domestic and sexual abuse or violence. Newton-Wellesley provides sexual assault nurse examiners (SANE) as well as advocates from the **Boston Area Rape Crisis Center**

(BARCC). SANE nurses are specially trained to assist and support the survivors without re-traumatizing the survivor during examination and evidence collection process.

What happens when you meet with the Title IX

- The Title IX staff member(s) will discuss resources and reporting options available to you. A community member will never be forced to participate in any part of the process until, and if, they would like to.
- The Title IX staff can also offer interim measures and accommodations, including:
  - issuing mutual No Contact Orders to all parties involved
  - Limiting access to University facilities and activities to some or all involved parties
  - Changes in housing assignments or room combination
  - Changes in course or course section registration
  - Change in class schedule
  - Assistance with academic support services
  - Arrangement for medical services
  - Alternative transportation arrangements

## **Rights under Title IX**

- You have the right to live and learn at Bentley University free from harassment or discrimination based on your sex, gender, sexual orientation, gender identity, or gender expression
- You have the right to file a complaint according to Bentley's Title IX and Gender-Based Harassment & Discrimination Policy. You also have the right to request a criminal investigation with law enforcement.
- you have the right to know and understand the different types of employees at Bentley, meaning who is confidential and who is not
- You have the right to understand what Bentley is required to undertake a prompt and thorough investigation of all reports of genderand -sex-based misconduct
- You have the right to interim support and reasonable protective measures to help you continue to live and learn at Bentley, including receiving a housing or academic modification, for example.
- You have the right to be free from retaliation for exercising your rights.
